Whenever there is more than one (1) use conducted on any one (1) premises, parking spaces shall be provided in accordance with the combined requirements of each use as shown on the above schedule or as approved by the Planning Board or Zoning Board of Adjustment or as otherwise indicated in this chapter.
- 3. Driver-through lanes and windows for banks and other uses, where permitted, shall be provided with room for queuing of ten (10) automobiles for each drive-through land and/or window.
- 4. The inclusion of any use in this table is not meant to imply it is a permitted us in the Township. See the applicable sections of this code for the enumeration of permitted uses.
