**RESOLUTION NO. R-24-75
RESOLUTION CONDITIONALLY AUTHORIZING PUBLIC
FIREWORKS DISPLAY FOR WHITE MEADOW LAKE PROPERTY
OWNERS' ASSOCIATION**

BE IT RESOLVED by the Township Council of the Township of Rockaway, County of Morris, State of New Jersey, that permission is hereby granted to the

WHITE MEADOW LAKE PROPERTY OWNERS' ASSOCIATION

for the public display of fireworks at White Meadow Lake Country Club in the Township of Rockaway on Sunday, July 21, 2024 at approximately 9:00 p.m. Said display shall be prepared and operated by a competent operator or operators, whose credentials must be approved by the Chief of Police, the Fire Department of the Township of Rockaway and the Fire Marshal/Official. Such display shall be of such character and so located, discharged or fixed in accordance with all of the requirements of the N.J. Department of Community Affairs for such activities, and the fireworks display company's compliance with such requirements shall be submitted to the Chief of Police, and Fire Marshal/Official along with all required supporting information for their review in order that the Township may rely upon the firework's operators' and White Meadow Lake Country Club's assurances that the firework display shall not be hazardous to property or endanger any persons.

The within permission is also conditioned upon Township's approval of the following documents to be received no later than ten (10) days prior to the scheduled event to be submitted by White Meadow Lake Property Owner's Association:

- (a) the appropriate bond pursuant to N.J.S.A. 21:3-1 et seq. and/or evidence of Vendor's liability insurance coverage, having a single limit of \$1,000,000.00;
- (b) evidence of an umbrella insurance policy having a single limit of \$4,000,000.00,
- (c) a completed permit Application for Fireworks Display, the fee for which has been previously submitted to the Fire Marshal/Official prior to the passage of this Resolution; and
- (d) a Township approved executed Hold Harmless Agreement in favor of Rockaway Township signed by White Meadow Lake Property Owners Association and/or the Permitted Vendor.
- (e) Township's approval of proofs of all insurance relevant hereto, which shall name Township of Rockaway as additional insureds and shall provide primary and non-contributory coverage to the Township and that the approval of the permits shall be subject to and contingent upon the Township Attorney's review and approval of said insurance.

(f) forwarding of a certified copy of the within Resolution the Bureau of Explosives of the Department of Labor by the Township Clerk , in accordance with the provisions of R.S. 21:3-1 et seq.

BE IT FURTHER RESOLVED that a permit shall not be issued until all conditions of the permit and this Resolution have been met; and

BE IT FURTHER RESOLVED that all relevant members of the administration are hereby authorized and directed to take all steps necessary to fulfill the purpose of this Resolution; and

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
