**AMENDING RESOLUTION R-25-18, R-25-100, R-25-134, and R-25-148 AUTHORIZING
PURCHASE OF CERTAIN GOODS AND SERVICES THROUGH THE USE OF STATE, COUNTY AND
REGIONAL COOPERATIVE CONTRACTS FOR THE YEAR 2025**

WHEREAS, the Local Public Contracts Law 40A:11-4 requires that every contract awarded by the contracting agent for the provision or performance of any goods or services, the cost of which in the aggregate exceeds the bid threshold, shall be awarded only by resolution of the governing body; and

WHEREAS, the State of New Jersey (State) and/or the Morris County Cooperative Pricing Council (MCCPC) and/or Somerset County Cooperative (SOCCP) and/or Educational Services Commission of New Jersey (ESCNJ), Union County Cooperative (UCNJ), Hunterdon Educational Services Commission (HESC) and/or Bergen County Cooperative Purchasing System (Bergen) and/or Passaic Valley Sewerage Commission (PVSC) have awarded contracts to various vendors as lowest responsible, responsive bidders for State, County and Regional Cooperative Pricing contracts; and

WHEREAS, the Township wishes to facilitate the purchase of goods and services by way of resolution for the purchase of items which are regularly used in connection with the Township's provision of services to the residents; and

WHEREAS, the Township of Rockaway desires to authorize the purchase of such items through approved State, MCCPC, SOCCP, ESCNJ, HESC, UCNJ, PVSC and/or Bergen contract vendors whether or not the cost of such items either individually or in the aggregate may exceed the prevailing bid threshold; and

WHEREAS, the list of the State, MCCPC, SOCCP, ESCNJ, HESC, UCNJ, PVSC and/or Bergen vendors whose goods and services the Township seeks to use by way of resolution are identified along with their State, MCCPC, SOCCP, ESCNJ, HESC, UCNJ, PVSC and/or Bergen contract numbers as follows:
