**RESOLUTION NO. R-22-57**

**RESOLUTION AUTHORIZING THE MAYOR TO SIGN A GRANT APPLICATION TO  
BE SUBMITTED TO THE NEW JERSEY HISTORIC TRUST PROGRAM FOR A 2022  
GRANT FOR THE PRESERVATION OF THE FORD-FAESCH MANOR HOUSE C.1772  
OWNED BY THE TOWNSHIP OF ROCKAWAY**

**WHEREAS**, the Township of Rockaway ("Township") is the owner in fee of the Ford-Faesch Manor House c.1772, located at 629 Mount Hope Road in Rockaway Township; and

**WHEREAS**, the Township maintains a lease agreement with the Historical Society of Rockaway Township ("Historical Society") for the purposes of stewardship of the structure and grounds; and

**WHEREAS**, the Township and the Historical Society have been engaged in a long-term restoration effort of the Ford-Faesch Manor House spanning over two decades; and

**WHEREAS**, in furtherance of the Township's ongoing participation in the Ford-Faesch Manor House restoration project, the Historical Society and the Administration have requested the Council's authorization to make a 2022 Capital Level I Grant Application to the New Jersey Historic Trust Preserve New Jersey Program for funds to be utilized for the partial interior restoration and roof replacement.

**WHEREAS**, The Township will be requesting \$ 68,390.00 through the grant application, which will require the Township to provide a "match" of \$ 273,560.00 for a total project estimated to be \$341,950.00; and


**WHEREAS**, the Township desires to continue to provide support for the preservation/restoration of the Ford-Faesch Manor House.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Rockaway, County of Morris, State of New Jersey as follows:

1. The Mayor is hereby authorized to sign and submit a grant application to the New Jersey Historic Trust for a 2022 Capital Level I Grant Application in the amount of \$68,390.00 to support the costs of the Phase VI: Partial Interior Restoration and Roof Replacement at the Ford-Faesch Manor House.
2. The Township's "match" of the grant funds in the amount of \$273,560.00 for a total project cost estimated to be \$341,950.00 is hereby approved.
3. All work will be performed in accordance with existing plans appropriate for the original historical appearance of the structure, in accordance with the updated Historic Structure Report (HSR) for the building.
4. this Resolution shall be submitted as part of the 2022 grant application package to be submitted to the New Jersey Historic Trust.
5. The Mayor, together with all other officers, professionals, and employees of the Township are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.
6. This Resolution shall take effect immediately.
