**RESOLUTION R-22-127**

**RESOLUTION AMENDING R-22-18 AND R-22-32 BY ADDING TO  
THAT RESOLUTION'S LIST OF AUTHORIZED VENDORS FOR THE  
PURCHASE OF CERTAIN GOODS AND SERVICES THROUGH THE  
USE OF STATE, COUNTY AND REGIONAL COOPERATIVE  
CONTRACTS FOR THE CALENDAR YEAR 2022**

**WHEREAS**, the Local Public Contracts Law 40A:11-4 requires that every contract awarded by the contracting agent for the provision or performance of any goods or services, the cost of which in the aggregate exceeds the bid threshold, shall be awarded only by resolution of the governing body; and

**WHEREAS**, the State of New Jersey (State) and/or the Morris County Cooperative Pricing Council (MCCPC) and/or Somerset County Cooperative (SOCCP) and/or Middlesex Regional Educational Services Commission (MRESC), Union County Cooperative (UCNJ) and/or Bergen County Cooperative Purchasing System (Bergen) have awarded contracts to various vendors as the lowest responsible, responsive bidders for State, County and Regional Cooperative Pricing contracts; and

**WHEREAS**, by the passage of Resolutions R-22-18 and R-22-32 the Township authorized the purchase of certain goods and services from vendors who had been awarded such contracts for purchases in the calendar year of 2022; and

**WHEREAS**, pursuant to Resolutions R-22-18 and R-22-32 the Township expressed its desire to facilitate the purchase of goods and services for the purchase of items which are regularly used in connection with the Township's provision of services to the residents; and

**WHEREAS**, the Township wishes to amend the list of Vendors set forth on R-22-18 and R-22-32, by adding a Vendor to the list of Vendors named on foregoing resolution as follows:



**WHEREAS**, the Township of Rockaway desires to authorize the purchase of such items through approved State and/or MCCPC, SOCCP, MRESC, UCNJ, Bergen contract vendors whether or not the cost of such items either individually or in the aggregate may exceed the prevailing bid threshold.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Council of the Township of Rockaway, County of Morris, State of New Jersey does hereby authorize the Mayor and/or Business Administrator or Assistant Business Administrator to authorize the purchase of the specified items from the above listed State and/or MCCPC, SOCCP, MRESC, UCNJ or Bergen County Cooperative vendors as often as deemed necessary and reasonable to do so without necessity of a bid, but only to the extent that such purchases do not exceed duly authorized budget appropriations for each category of purchases/expenditures.
